If it is found at a later stage, during active verification, that the candidate has given false information / qualification obtained from an unrecognized Board / University **OR** is found to have concealed some information regarding the eligibility / deliberately delayed submission of marks / grade sheets, in spite of multiple reminders; his / her admission will be cancelled without any notice and the paid fee will be forfeited.
 - o In case the candidate submits fake documents (if any), the full fee paid by the candidate shall be forfeited.
