## What is CSR?

- Corporate social responsibility is a business model by which companies make a concerted effort to operate in ways that enhance rather than degrade society and the environment.
- CSR helps both improve various aspects of society as well as promote a positive brand image of companies.

#### **Applicability and Compliance Requirements:**

- Companies Act 2013 (Co Act) require companies meeting certain criteria to spend on CSR w.e.f. 1st April 2014.
- Section 135 of the Companies Act 2013 mandates that a company with (1) net worth ≥ Rs. 500 crores or more; or (2) turnover ≥ Rs. 1000 crores or more; or (3) net profit ≥ Rs. 5 crores, to spend 2 % of their average net profit for the immediately preceding three years on CSR.
- As per the Companies (Corporate Social Responsibility Policy) Rules, 2014; "Corporate Social Responsibility Rules, 2014, Corporate Social Responsibility means;

The projects or programs relating to activities specified in Schedule VII of the Act as mentioned in this section or (ii) projects or programs relating to activities undertaken by the Board as per recommendations of the CSR committee & as per CSR policy of the company.

The notification issued by the Ministry of Corporate Affairs on 23<sup>rd</sup> March, 2020 seeks to include funds spent on various activities related to COVID-19 covered under the existing items under Schedule VII of the Companies Act, 2013. This has been done because the World Health Organization declared Coronavirus as a global pandemic and subsequently the Government of India decided to treat it as a notified disaster.

## CSR activities as per Schedule VII of the Companies Act:

- 1. Eradicating hunger, poverty and malnutrition.
- 2. Promotion of education including employment enhancing vocational skills.
- 3. Promotion of gender equality/empowering women.
- 4. Ensuring environmental sustainability, ecological balance.
- 5. Contribution to the prime minister's national relief fund.
- 6. Training to promote rural sports, nationally recognized sports etc.
- 7. Protection of national heritage, art and culture.

## **Details of the CSR projects and Principal Investigators:**

Acuvate Software Pvt. Ltd., Hyderabad has funded Rs. 8,00,000/for the core research activities of MAHE. Out of which Rs. 4,74,000/is being utilised for the Conceptual Design, Prototype Development, in house Fabrication and Testing of indigenous Unmanned Aerial Vehicle (UAV) systems for all weather applications.



Rs. 2,24,000/- is being utilised to generate a gene knockout mouse line. This mouse line is being produced in the Mouse Genome Engineering Facility (MGEF), InStem, National Centre for Biological Sciences (NCBS), Bangalore and is currently in its final phase; the mice are likely to be delivered in February, 2023. These mice will be used in research pertaining to regulation of male germ cell production.

And, Rs. 1,02,000 will be used to study the mRNA methylation in mammalian systems and its implication on RNA transport, its stability/decay, and translational efficiency.

• Royal Enfield (A Unit of Eicher Motors Ltd.) has donated a motorcycle (CLASSIC 350 ASH) to Manipal Institute of Technology, MIT, Manipal under CSR initiative of the company. It's being used to demonstrate the two-wheeler systems such as engine, brake system, suspensions system etc, to the 3rd and 4th semester Automobile Engineering students as a part of their laboratory course.

## **Impact of Kotak Securities Limited - Childhood Cancer Project**

The major impact of the project has been the reduction of treatment abandonment and refusal. Of the total 140 patients registered and taking treatment in the division of Pediatric

Hematology and Oncology, Kasturba Medical College and Kasturba Hospital, Manipal during period of this project, there have been **0** (zero) treatment refusals or treatment abandonment.

Around 52 patients have been supported till date, who are not eligible for any schemes or who were not eligible for certain components of the funding through their schemes. The beneficiaries have been selected after thorough due diligence and ensuring that the fund is transferred to the right family.

## Current status of the children needing bone marrow transplant project

Under this project four children have been screened and the funds are being utilised for two deserving children. Following are the details of the same:

- 1. Autologous transplant Rs 4.5 lakhs
- 2. Allogenic transplant Rs 9.5 lakhs

Total of Rs 14 lakhs is being used for these two patients. Currently both children are undergoing the transplant and are admitted at Kasturba Hospital, Manipal.

• Shriram General Insurance Co. Ltd. Jaipur/ Shriram Seva Sankalp Foundation,

**Chennai** both organisations have funded Rs. 50,00,000/and 25,00,000/- respectively for the project titled 'Human Microbiome Research'. The objective of this project is to benefit Indian population through Microbiome Research and to understand its relevance to health and disease. Metagenomic analyses of microbial communities in humans will enable to develop targeted solutions that work on root cause resolution for difficult to treat disease conditions such as colorectal cancer, urticaria, psoriasis, neonatal distress and autism.

The project aims to deliver comprehensive care with 24x7 on call services to patients with low economic resources, support system, multiple comorbid conditions, challenges in accessing health care and those needing long term engagement for dealing with their mental health problems.

#### CSR fund utilization mechanism:

- In order to attract CSR funds, Heads of MAHE institutions /departments /centres are urged to approach the corporates they are associated with, to raise CSR funds.
- As per the new CSR policy (internal) regarding fund utilization, MAHE would allocate 100% of the CSR funds for utilization by the MAHE investigators who have secured CSR grants for specific projects.
- If the purpose mentioned by the CSR fund giver is of broader scope like core scientific research, then 70% of such funds can be allocated to the Institutions/Departments /Centers responsible for raising such funds.
