#### ABSTRACT SUBMISSION GUIDELINES

- 1. Only registered delegates are allowed to present.
- 2. Abstracts should not exceed 250 words.
- 3. Abstracts to be typed in MS Word in Times New Roman font & size -12.
- 4. The title of the abstract should be in UPPERCASE, short and concise.
- Next line should have the name of authors with the presenting author being first and name should be underlined.
- Next line should have designation of the presenting author, institution, city and state.
- 7. Do not include professional degrees.
- For Original articles, the abstract should be structured under following headings
  - Introduction
  - Objectives
  - Methods
  - Results
  - Conclusion.
- Avoid "it will be discussed" "numbers will be presented" etc. Results have to be written.
- 10. For Case reports, the abstract should be structured under following headings
  - Introduction
  - · Case details
  - Discussion
- 11. Standard abbreviations are allowed. Do not include graphs, images and references in abstracts.
- 12. Abstracts to be emailed as an attachment by 1 October, 2018 to kamlscon2018@gmail.com (only e-mail abstracts will be accepted).
- Final decision regarding the acceptance of the abstract rests on the scientific committee.
- 14. The presentations for oral papers and e-posters have to be emailed before the conference. The date will be mailed to the authors. The time limit for oral presentation will be 7 minutes followed by a short discussion.
- 15. Only e-poster will be accepted. The poster should be designed in the landscape mode. The size of the poster should be 16:9 for preparation in the MS Power Pointformat.
- 16. E-poster will be projected on screen for evaluation by judges for maximum of 3 minutes. The author should be present for evaluation.
- 17. Prize will be given for best Poster and Oral paper under 3 categories-Undergraduate, Postgraduate and Faculty category.

We have made an alliance with a Scopus indexed Forensic Medicine Journal for publication of papers presented in the conference. The acceptance of the same will be based on the journal's editorial board and peer review process. The papers have to be submitted as per the Manuscript submission guidelines of the journal.

## **About Manipal**

Manipal is a town located 5 kilometres from Udupi district in Karnataka, India. It is located in the part of Coastal Karnataka, about 63 km north of Mangalore and 8 km east of the Arabian Sea. From its location on a plateau, it commands a panoramic view of the Arabian Sea to the west and the Western Ghats to the east.

The name is derived from "mann" and "palla", anglicised to Manipal. Mann means "mud" and palla means "lake" in Tulu language. This lake, roughly a 400m diameter circle, after which Manipal is named, is located in the middle of the town, and offers boating facilities.

Manipal was once a barren hill with few trees. This hill was transformed to a university town by Dr. T. M. A. Pai, who first started the Kasturba Medical College in 1953, now ranked among top 5 private medical institutions of India.

Manipal is connected to Mangalore and towns such as Udupi, Karkala and Kundapur by several private bus services and KSRTC City Buses which run every few minutes. The nearest railway station is at Udupi located 5km away and the nearest airport is Mangalore Airport which is 60 km away.
